

IMPORTANT INFORMATION ABOUT YOUR TRANSITCHEK® COMMUTER BENEFITS PROGRAM

Effective with the **June benefit month**, your commuter benefits program is transitioning from TransitChek to HealthEquity, a leading provider of consumer-directed benefits in the United States. Your commuter benefit elections will automatically be migrated to the HealthEquity platform and you will continue to receive a commuter benefit. Please see below for key dates and upcoming system disruption activities that may affect you during this transition period.

March 31, 2021	<ul style="list-style-type: none"> ➤ Last day to make elections on the TransitChek Account Management System (TAMS) at http://tams.transitchek.com/ for the May 2021 benefit month, if needed. If you do not have an ACTIVE election today, and want to receive a Commuter Card for the June Benefit Month to insure your balance is transferred you will need to place an order prior to March 31 for a minimum of \$15.
May 1, 2021 - May 31, 2021	<ul style="list-style-type: none"> ➤ During this time, <i>you will be unable to access TAMS to change your elections.</i> However, you may still log in TAMS to view your account until May 31, 2021. Any election changes for future benefit months can be done starting on April 23, 2021 in the new system.
April 23, 2021 - May 10, 2021	<ul style="list-style-type: none"> ➤ You will receive a communication from your employer inviting you to register your new account on the HealthEquity platform at www.HealthEquity.Wageworks.com ➤ You should review your migrated election and consider other transit and parking options available to you on the HealthEquity platform. If you would like to make any changes, you have until May 10th to do so for the June benefit month.
May 20-31, 2021	<ul style="list-style-type: none"> ➤ Expect to receive your transit fare media, transit and/or parking debit cards through the mail prior to the beginning of the upcoming benefit month. ➤ Transit funds load to Commuter Cards on May 20
June 1, 2021	<ul style="list-style-type: none"> ➤ You will no longer have access to TAMS to view your account. ➤ TransitChek QuickPay Cards will stop working. <ul style="list-style-type: none"> ➤ Any remaining pretax funds will be moved to your new HealthEquity account in mid-June. ➤ Any remaining post tax funds \$1 and higher will be refunded to you via a check sent to your home by the end of June. ➤ Last day to submit reimbursements through TAMS for CashBack participants <ul style="list-style-type: none"> ➤ Any parking expenses for the CashBack parking program incurred through May 31, 2021 can be submitted via paper claim form until June 30, 2021. ➤ Any remaining pretax funds will be moved to your new HealthEquity account in mid-July as Commuter Credits to be used for a future month election. ➤ Parking funds load to Commuter Cards June 1
June 1, 2021	<ul style="list-style-type: none"> ➤ Your new benefit will be available through the HealthEquity platform at www.HealthEquity.Wageworks.com. <ul style="list-style-type: none"> ➤ NOTE: any funds in your TransitChek Cashback account or on your QuickPay card as of May 31, 2021 may take several weeks to appear on the HealthEquity platform.
