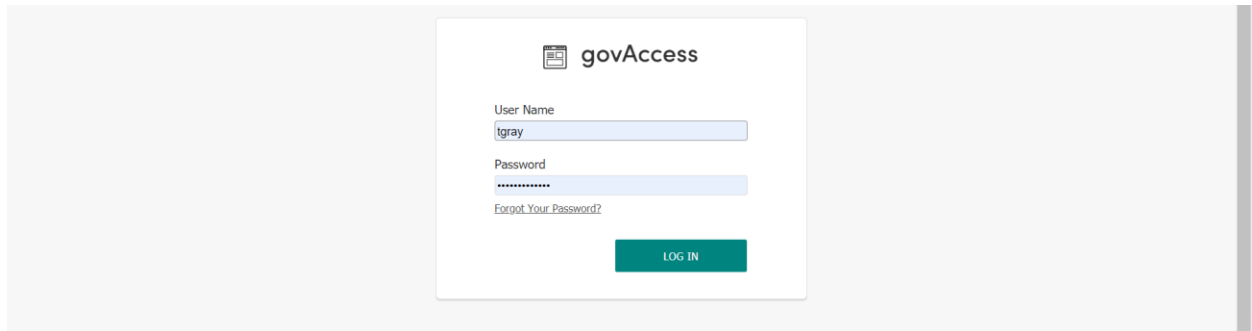


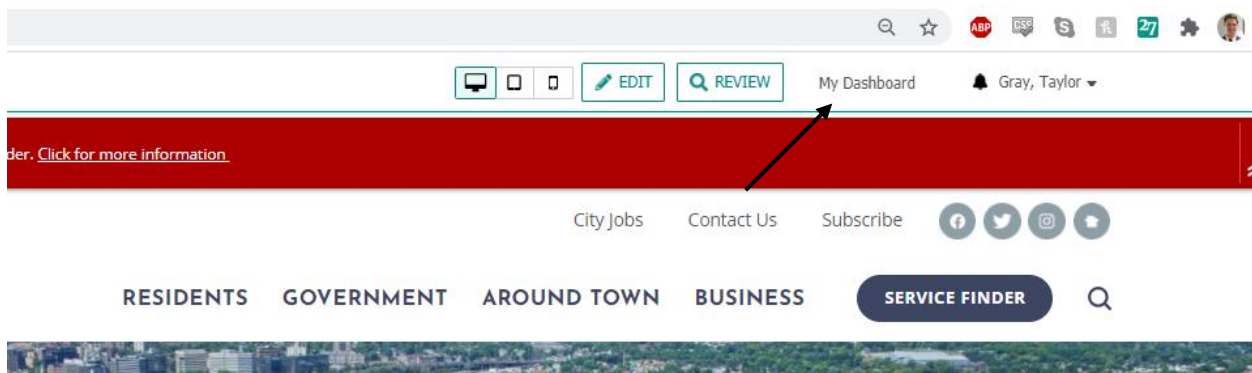
How to Publish Minutes and Agendas onto the City of Stamford Website.

Please use this guide to learn how to publish a minute or agenda onto the city website.

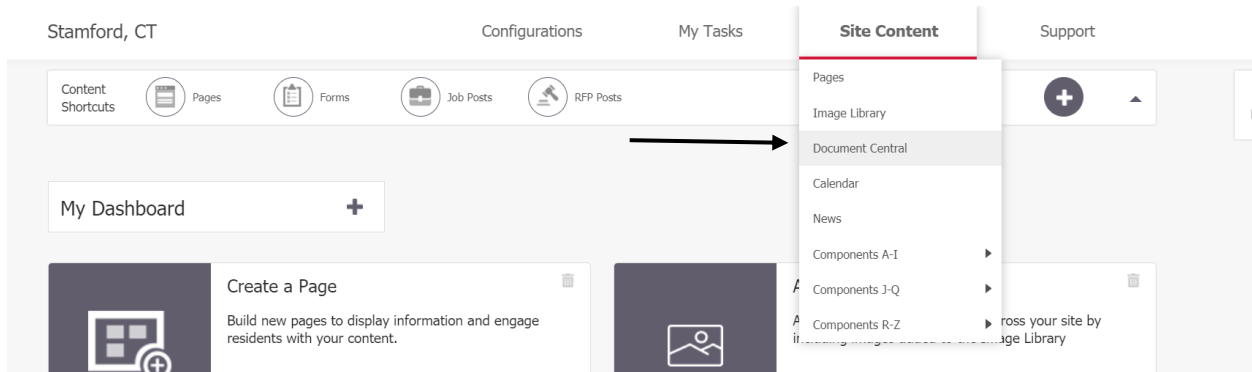
1) Log Into the website.



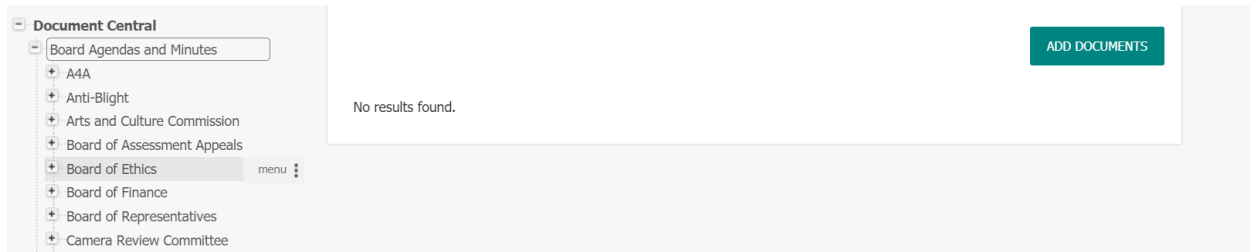
2) Click my Dashboard.



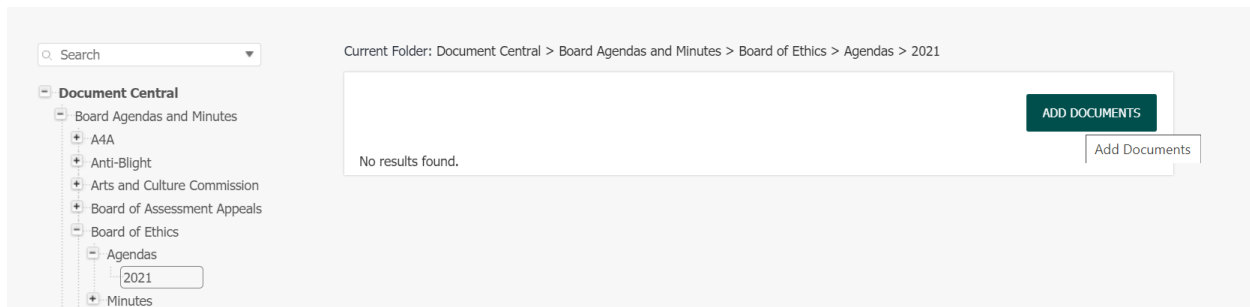
3) Highlight Site Content > Document Central



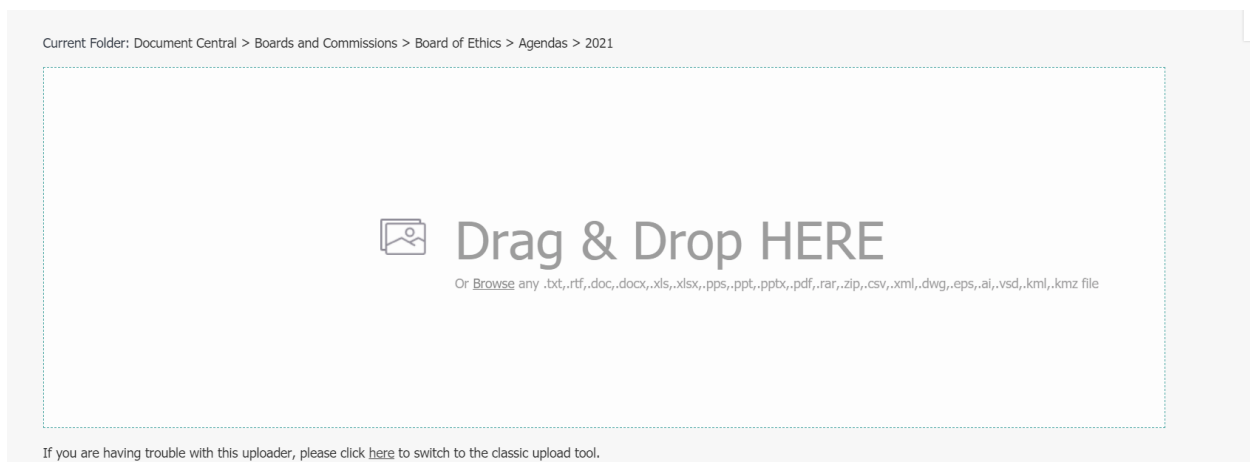
- 4) Click the plus button next to Board Agendas and Minutes on the left hand side and find the Board you are looking for and click the plus button.



- 5) Click the plus button next to either the minutes or agendas folder then click the corresponding year of the document and press “Add Documents”.



- 6) Drag the document into the space titled “Drag & Drop HERE” or press the space and find the pdf in your folders. You can drag up to twenty documents at a time.



- 7) Pick out your content group. For the majority of Boards and Commissions, the content group should be Boards and Commissions. There are a few exceptions (Board of Finance, Land Use Boards)
